



THE SPECIAL PROTECTION FOR UNACCOMPANIED MINORS IN ITALY



*"(...) A minor who is not an Italian or EU citizen, who for whatever reason is found in Italian territory or is subject to Italian jurisdiction, lacking **assistance or representation of his parents or other adults** who would be responsible for him according to Italian legislation". (Article 2 (1) Law No. 47 of April 7, 2017)*







UNACCOMPANIED MINORS IN ITALY AS OF 31/12/2020



Most represented citizenships




FORMER UNACCOMPANIED MINORS IN ITALY – 18/21 YEARS OLD AS OF DECEMBER 2020

Under specific conditions, UAMS holding a residence permit for minor age, can obtain a new permit for



- The Ministry is requested to issue a mandatory formal opinion on the **LEVEL OF INTEGRATION**, if UAMS turned 18 is in Italy for less than 3 years.

Aimed at enhancing a sustainable intervention Model that caters to the social and working placement of the unaccompanied minor refugees, based on the local system for integration and working services.

Tailored intervention plan for UAMs and young refugees (starting from 16 years old – up to 23 years old) who arrived in Italy as unaccompanied and are unemployed or inactive (internships and integrated services offer).





[...] The transition into adulthood and from school to work can be particularly challenging for recently arrived migrant children, in particular unaccompanied young people, not least because support measures often stop when a child reaches 18 years of age. Preparing for such a transition in advance – through supporting their educational achievement, including them in vocational education and training and in the Youth Guarantee, and providing coaching and mentoring – can be particularly effective [...]
