FROM THE AIRPORT TO THE CITY CENTER (CENTRAL TRAIN STATION)

Bus 29 will take you from the airport to the city center (the Central train station, *Luxembourg Gare Centrale*) without additional transfers.

Bus 29 leaves from Platform 3 every 15 min. Travel time to city center is around 20 minutes. The first bus of the day departs at 04:43, and the last leaves at 23:50.

The tram will take you from the airport to the city center (the Central train station, *Luxembourg Gare Centrale*) without additional transfers.

The tram leaves every 8 min. Travel time to city center is around 30 minutes. The first tram of the day departs at 04:20, and the last leaves at 00:06.
